1. **Call to Order: Meeting called to order at 6 pm.**

2. **Approval of Agenda:**

**Motion:** Moved by L. Jansen, seconded by W. Hilgendag, that the agenda of the November 14, 2023 meeting of the Board of Directors be approved.

3. **Approval of Minutes:**

**Motion:** Moved by M-A Marion, seconded by W. Hilgendag that the Minutes of the October 3, 2023 meeting of the Board of Directors be approved.

**Carried unanimously.**

4. **Executive Director's Report:**

M. McGeein reported that she has completed the new job descriptions for staff and presented them for each to sign.

She has also begun holding team meetings every two weeks. IT issues continue to be a challenge. She and staff are working on each in turn. Finances are also a challenge. She has written an application for a grant to improve security for the building to curb the problem of homeless and trespassers. M. McGeein lauded the opening of the exhibit on the Boer War and World War I. She reported and upcoming Christmas Social at Myrtleville House Museum on December 20, 2023 at 7 pm.

**Motion:** Moved by M-A. Marion, seconded by L. Jansen, that the report of the Executive Director be approved.

**5. Treasurer's Report:**

The latest financial documents were circulated before the meeting. W. Hilgendorf briefly discussed their highlights.

He also delivered a separate written and verbal report in which he expressed his concerns that the earlier unknown financial costs that had to be borne in moving the Crystal Cottage and re-situating it on a vacant lot beside the Brant Museum are now hampering the Society's ability to carry on its overall operations.

He also raised questions about some of the costs that the Society might have to bear if it were to take over Myrtleville House Museum, because historical buildings like the Crystal Cottage and Myrtleville will need construction work.

And he said it is important for the Society to seek out other sources of funding to ensure its future well-being. "We need to find major benefactors, like we enjoyed...years ago."

**A) Resignation of Denise Methot**

The Board was read a letter of resignation from Vice-President D. Methot, who served the Society and the Board of Directors for several years, and served as Vice-President for three years.

a notice in a newsletter and on the website calling for interested people to apply. A committee will be set up to go over applications.
